**Key Points:** 

- Consult your tax prepare for professional advice regarding your individual tax situation. The tax law for grain donations is very complex and specific criteria must be met.
- A representative from St. Gabriel Communications/Siouxland Catholic Radio will open an account with the elevator in anticipation of the grain donation. Please contact us in advance so an account can be established prior to delivery.
- The farmer must deliver grain to the elevator or currently hold grain in their name to provide proof of production. Contracted grain sales will not be accepted.
- The farmer must transfer ownership title of the commodity to **St. Gabriel Communications/Siouxland Catholic Radio.**
- St. Gabriel Communications/Siouxland Catholic Radio must make the final decision to sell the grain.
